**DECLARATION OF LARRY LEWIS IN
SUPPORT OF VERIFIED PETITION FOR
WRIT OF MANDATE**

PRIORITY ELECTION MATTER
(Cal. Elec. Code § 13314)

ACTION REQUIRED BY:
November 6, 2024

I, Larry Lewis, the undersigned, declare as follows:

1 1. I am a United States Citizen over the age of eighteen years and am a party to the
2 above-referenced action. I make this declaration based on my own firsthand knowledge unless stated
3 otherwise. If called to testify as a witness, I could and would testify competently thereto.

4 2. I make this declaration in support of Petitioners' Verified Peremptory Writ of
5 Mandate.

6 3. I am a registered voter in the County of Los Angeles, State of California and am
7 currently a resident of Los Angeles County, California.

8 4. I voted in the 2022 midterm election, which was held on November 8, 2022, and was
9 a Los Angeles County resident prior to, and at the time of, the November 2022 election. I also intend
10 to vote in the 2024 general election on November 5, 2024.

11 5. I am a volunteer election observer for Election Integrity Project California
12 ("EIPCa"), a Petitioner in this action. The EIPCa is a nonpartisan nonprofit 501(c)(3) nonprofit
13 public benefit corporation committed to defending, through education, research, and advocacy the
14 civil rights of United States citizens to fully participate in the election process under Federal and
15 state law. I first started training with the EIPCa in 2022. At that time, I served as a "Citizen
16 Observer" with the oversight of the Los Angeles County Coordinator for the EIPCa. As a "Citizen
17 Observer," I observed both the 2022 primary and general midterm elections for Los Angeles County.

18 6. I became an official member of EIPCa in December of 2023 and participated in
19 EIPCa's Citizen Observation Education program prior to serving as an EIPCa election observer. I
20 completed this training program in February of 2024. Through participating in this program, I was
21 trained on how to observe the election processes and document any observed election irregularities.

22 7. I currently serve as an Assistant Coordinator for EIPCa in Los Angeles County,
23 where I am observing, and will continue to observe, election processes associated with the
24 November 2024 general election.

25 8. As both a voter and a volunteer observer of elections, I understand the importance of
26 ensuring that each lawfully cast vote is accurately counted. Thus, I bring the present Petition to

1 request that my county elections official and the Secretary of State participate in an accurate count
2 and proper certification of the votes cast in the November 2024 election.

3 I declare under penalty of perjury under the laws of the State of California that the foregoing
4 is true and correct.
